APPROVAL OF AGENDA

Schilling made the motion to approve the agenda. Second by Eipers. A voice vote was called on the motion. *Motion to approve the January 2, 2024 regular meeting agenda carried unanimously.*

Member voting yea: Dominick, Eipers, D Scudder and Shuman. Members voting nay: Schilling. *Motion to approve Ordinance 0102-24 Liquor Serving Age carried.*

Discussion – ground water ordinance (old gas station)

Need to create ordinance for any wells that me be dug in future, limits/boundaries of where can be dug. Tabled for future discussion.

NEW BUSINESS

Discussion of Debt Service Rate Increase

Pepin explained need to increase/collect more debt service to be able to repay IEPA loan that will be needed for future projects. Phase 1 to increase debt service fee \$8.07/month per customer for 20 year loan, \$5.05/month for 30 year loan. Decision for \$8.07/month increase. Will have informational meeting February 6, 2024 at 6:30 pm.
