Water Rate Increase - Wagner presented proposal for IEPA loan - waterworks improvements. Dominick motioned to approve Wagner's proposal for the waterworks improvement plan. Second by Eipers. The Clerk called for a

roll call vote on the motion. Members voting yea: Dominick, Eipers, Parriott, Schilling and Siedschlag. Zero voted nay. *Motion to approve Wagner's proposal for the waterworks improvement plan carried unanimously.*

Currently \$5/first 2000 gallons. \$2.50/each additional 1000 gallons. Discussion to change to \$8/first 2000 gallons and \$4.50/each additional 1000 gallons. Motion by Dominick to approve water rate increase of \$8/first 2000 gallons, \$4.50/each additional 1000 gallons and an additional \$2 debt service fee. Motion second by Eipers. A roll call vote was called on the motion. Members voting yea: Dominick, Eipers, Parriott, Schilling and Siedschlag. Zero voted nay. *Motion to approve water rate increase of \$8/first 2000 gallons, \$4.50/each additional 1000 gallons and an additional \$2 debt service fee carried unanimously.*

## Skid Steer – replacement/sale

Scudder raised a concern of a contract to purchase so Village isn't stuck with 2 skid steers. Motion by Siedschlag to purchase new skid steer for \$62,777 and sell current skid steer when new skid steer arrives. Motion second by Dominick. A roll was called on the motion. Members voting yea: Dominick, Eipers, Parriott, Schilling and Siedschlag. Zero voted nay. *Motion to purchase new skid steer for \$62,777 and sell current skid steer when new skid steer arrives carried unanimously.* 

## Street Light - quote

Pro Source estimate for street light on Samuelson Dr & Orangeville Rd for \$13,800. Could use TIF money for improvement. Tabled for TIF meeting.

## Community Bank/alternate location for disaster

Motion by Siedschlag to allow Community Bank to use the Village Hall for alternate sight incase of disaster. Second by Schilling. A voice vote was called on the motion. *Motion to allow Community Bank to use the Village Hall for alternate sight incase of disaster carried unanimously.*

Members voting yea: Dominick, Eipers, Parriott, Schilling and Siedschlag. Zero voted nay. *Motion to amend Shane's contract to limit his vacation carry over to 40 hours per year and use the remainder hour or lose them carried unanimously.*
