The Orangeville Village Board met at the Village Hall on Monday, October 2, 2023. The meeting was called to order at 7:00 pm. President Scudder opened the meeting with the pledge. The roll was called. Members present: Tom Scudder, Jackie Dominick, Nichole Eipers, Kurt Schilling, Denise Scudder, Theresa Shuman, Michael Schindler and Toni Koester. Zero absent.

APPROVAL OF AGENDA

D. Scudder made the motion to approve the agenda as presented. Second by Dominick. A voice vote was called on the motion. *Motion to approve the October 2, 2023 regular meeting agenda as presented carried unanimously.*

PUBLIC COMMENT & COMMUNICATION

Received a call from a person running in town, charged by a dog that was on owner's porch, not on a leash. The dog growled and made her feel very uneasy. Passer-byes stopped as they witnessed the dog's behavior. The owner grabbed the dog before anything happened. The runner later asked the owner if the dog normally acts in this manner and asked if it were a child, how would the dog react? She told the dog owner they would be reported for this incident. President Scudder to talk with dog owner. ***There is a leash law ordinance. If your animal is outside, it must be on a leash or in a fenced area.***
